

## LEBANON TRANSIT CONTEST OFFICIAL RULES

Lebanon Transit will conduct the “**Look Who’s 40**” Contest (the “Contest”) substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open to all, who have not won a prize from Lebanon Transit in the last 30 days. **Void where prohibited by law.** Employees of Lebanon Transit, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, and the immediate family members and household members of all such employees are not eligible to participate. The term “immediate family members” includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term “household members” refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Lebanon Transit’s decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest will begin at **9:00 am ET on 12/09/2019** and will run through **3:00pm ET on 12/20/2019** (the “Contest Period”). Lebanon Transit’s computer is the official time keeping device for this Contest.

3. **How to Enter.** To enter:

**Online:** Lebanon Transit’s Facebook page. During the Contest Period, Contestants can post their selfies with the 40<sup>th</sup> Logo” on Lebanon Transit’s FB page. Contestants can also post their selfie on Instagram with the #LebanonTransit. All entries must be posted by 3:00 pm ET on 12/20/2019 to be eligible for the Prize drawing. Lebanon Transit is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Lebanon Transit and will not be returned. Lebanon Transit reserves the right to contact entrants. No mail-in entries will be accepted.

4. **Winner Selection.** On or about 3:30 pm ET on 12/20/ 2019, Lebanon Transit will select four (4) entries for the Prizes in a random drawing from among all valid entries received by Lebanon Transit during the Contest Period. The winning entrant will be contacted using the social media platform provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Lebanon Transit’s decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY LEBANON TRANSIT WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Lebanon Transit, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Lebanon Transit may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

6. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of Lebanon Transit, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Lebanon Transit, and its subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.
7. **Publicity.** Participation in the Contest constitutes winner's consent to use by Lebanon Transit and its agent of winner's name, likeness, photograph, voice, opinions and/or biographical information (including hometown and state) for promotional purposes in any media, worldwide, without further payment or consideration, unless otherwise prohibited by law.
8. **General Conditions.** Lebanon Transit reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Lebanon Transit's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Lebanon Transit in its sole discretion. Lebanon Transit reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Lebanon Transit reserves the right to seek damages from any such person to the fullest extent permitted by law. Lebanon Transit's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
9. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Lebanon Transit, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Lebanon Transit reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
