The review focused on 23 areas of compliance, and no findings or deficiencies were identified. The FTA commended Lebanon Transit for having all requested data readily available and well-organized. Notably, they also recognized LT as the first agency to achieve three consecutive no-finding reviews. A final report will be sent to Franklin Shearer, Board Chair, and myself by the end of September 2025.
